All concerned with MS-CIT Examination are hereby informed that, the MSBTE has decided to allow rescheduling of Learners who remain absent for final MS-CIT examination because the learner has to appear for other examination during the same period. This facility will be available subject to condition that; the learner / his parents / representative of Learners ALC arrange to submit valid documents (Attested Copy of hall ticket or Admit card and Attested Extract of copy of Examination days' time table of other examination he is appearing) to MS-CIT examination center before scheduled time and date of his MS-CIT examination. The controller of MS-CIT Examination center will verify the copies of documents submitted by learner and on his satisfaction he will reschedule such learners during same examination event in suitable slot.

The Examination center shall submit all such documents received from learners to RBTE through Examination center Slot wise report and attendance report file. Final Result of such learners will be validated and declared by MSBTE only after verifying the documents submitted by learner/s.

The circulars mentioned at Sr. no 2 and 3 under reference above stands cancelled with immediate effect and are withdrawn. **This circular will take immediate effect and shall be applicable from MS-CIT, May 2010 Examination event. All learners remaining Absent due to any reason other than the reason mentioned above shall be marked as Absent for the examination and will have to Re-appear in next examination by paying the prescribed examination fee.**

All concerned with MS-CIT examinations are requested to note the contents of this circular and communicate to the concerned learners as well as take suitable action at the time of Examination.
